Groundskeeping Services Thea Bowman Leadership Academy

I. Introduction

Thea Bowman Leadership Academy (TBLA) is soliciting proposals from qualified, licensed, and bonded vendors to provide comprehensive groundskeeping services for our campus. II. Scope of Services

Vendors are asked to provide itemized pricing and service plans for the following:

A. Landscaping Services

B. Lawn Care and Mowing Services

- Removal of clippings and debris.
- Aeration and overseeding as required.

C. Snow and Ice Removal Services

- Plowing of parking lots and driveways.
- Shoveling and salting of sidewalks and walkways.
- Ice prevention and treatment as necessary.
- Emergency snow/ice removal response.

III. Vendor Requirements

- Must be fully licensed and bonded.
- Must have experience providing groundskeeping services for schools, institutions, or comparable facilities.
- Must provide proof of insurance coverage.
- Must be able to meet the designated schedule of services.
